Dear Mr. Unwin,

## "THE SECRET SERVICE"

This is to confirm that we have engaged and you have agreed to render your services to us in connection with the production of the above series of 26 Supermarionation television films ("the series") upon and subject to the following terms and conditions.

- 1. You agree that we shall have first call on your services for the period from 15th July to 23rd December, 1968.

  During such period you agree:-
  - (A) to render such services in such studios as may be required of you in accordance with the provisions of the two attached engagement forms ("the Equity Engagements") by way of recording dialogue for sound tracks and appearing before the cameras to perform the part of Father Unwin all in respect of the Series;
  - (B) to attend such sittings and to assist in such processes as we may reasonably require to enable a puppet with a facsimile of your face in the make-up and pose of Father Unwin as portrayed by you to be made for use in the Series.
- You hereby confirm your consent to the making and use in the Series of the said puppet but acknowledge that any copyright and all other rights in both the said puppet and the character Father Unwin (including your portrayal of the character) belong to us absolutely.

- Accordingly it is further mutually agreed between us that you will not perform, portray or otherwise make use of your portrayal of the character of Father Unwin or any likeness thereof in any medium for the benefit of any third party without our prior consent which shall not unreasonably be witheld in respect of any such use which will not be contrary to the provisions of the Television Act 1964 or the requirements of the Independent Television Authority with respect to the use of programme material in any advertising context and for which a suitable fee payable to us shall have first been agreed.
- 4. By way of remuneration for all services rendered by you in accordance with this agreement we agree that you shall receive not less than £250 in respect of each film in the Series which shall include the salary and Exploitation Fee payable under each of the two Equity Engagements but shall not include the various percentages of the said Exploitation Fee for additional transmissions. The payment of £250 shall be made up upon and subject to the completion of your services in connection with each film. In the event of the payment of salary or Exploitation Fees being suspended under the provisions of either of the Equity Engagements you shall be entitled to such proportion of the remainder of the said £250 in respect of those films in the Series affected as shall fairly be attributed to the services already rendered by you in connection with those films.
- 5. We shall have an exclusive option exercisable by written notice to you on or before 1st November, 1968 to extend your engagement hereunder (including the Equity Engagements) to a further thirteen films in the Series during a further period of first call of thirteen weeks otherwise upon and subject to all the same terms. Thereafter we shall be entitled, subject in each case to the exercise of the preceding option, to similar successive options in respect of thirteen films and an additional period of first call of thirteen weeks each exercisable by written notice on or before the date two months before the expiry of the first call period under the previous option.
